### Annex I - Conditions of the Use of Materials available on the Hong Kong Observatory Website for Non-commercial Purposes

You may be authorised to disseminate, reproduce, adapt, distribute or print the contents available on this website (the “Materials”) of the Hong Kong Observatory (the “Observatory”) or make available copies of the Materials to the public or build hyperlink by surface linking to this website of the Observatory for **non-commercial purposes** on a free-of-charge basis on the following conditions (the “Conditions”):

1. The authorisation only applies to the use of the Materials prepared by the Observatory and owned by the Government of the Hong Kong Special Administrative Region (the “Government”).
2. The intellectual property rights in the Materials are solely owned by the Government or have been licensed to the Government by the intellectual property rights’ owner(s) of the Materials to deal with such Materials for the purposes of all activities contemplated on the Observatory’s website.
3. The Materials must be reproduced accurately and must not be used in a misleading context or in any manner adversely affecting the moral rights of the Government.
4. In all copies made by you including but not limited to paper copies, digital copies and copies placed on other websites:
  - (a) The Government must be acknowledged as the intellectual property rights’ owner of the Materials;
  - (b) Acknowledgement must be given to the Observatory and its website <https://www.weather.gov.hk> or <https://www.hko.gov.hk> as the source of the Materials; and
  - (c) The Intellectual Property Rights Notice and the Conditions herein must be reproduced.
5. You shall indemnify the Government against all costs, losses, damages and liabilities of whatsoever nature arising directly or indirectly from any allegations or claims that your use, reproduction and/or distribution of the Materials infringe any rights including but not limited to the intellectual property rights of any person.
6. You shall display the following Disclaimer or the Trade Mark of the Observatory (<https://www.weather.gov.hk/abouthko/logoexplain/logoexplaine.htm>) which also means the agreement to the Disclaimer prominently with any Materials that is distributed or reproduced by you:-

8. You shall not in any circumstances acquire any intellectual property rights in the Materials.
